## Have you been discriminated against? Need legal help?

The Human Rights Legal Support Centre (HRLSC) provides free legal help to people who have experienced discrimination in Ontario.

#### **Human Rights Legal Support Centre**

The Human Rights Legal Support Centre (HRLSC) gives legal help to people who have experienced discrimination under the Ontario Human Rights Code.

### including:

- Advice about whether your situation is covered by the Code
- Assistance in finding a solution
- Assistance to try to settle your claim early
- Help with a human rights application to the Ontario **Human Rights Tribunal** (HRTO)
- Representation in settlement negotiations
- Representation at your Tribunal mediation and hearing
- **Enforcement of a Tribunal** order or mediated settlement.

The HRLSC provides free The Code can protect you from being legal and support services treated differently and negatively in specific social settings:

- Employment/Jobs
- Housing
- Programs or government services (e.g. schools, transit or police)
- Stores, restaurants, etc.

#### The Code's goal is to prevent discrimination and harassment because of your:

- Race, colour, ancestry, place of origin, citizenship, ethnic origin
- Creed (religion)
- Receipt of public assistance (applies only to housing situations)
- Marital status and family status
- Record of offences (applies only to employment and the person must have been pardoned)
- Age
- Disability (visible or invisible)
- Gender or sex (sexual orientation, pregnancy, sexual harassment, gender identity/expression).



We can provide service in 140 languages, including Cree, Oji-Cree, Mohawk and Ojibway. We will arrange to speak with you in the language of your choice.

#### Stopping discrimination

If you have experienced discrimination, the HRLSC can help you get financial compensation for the harm it caused.

The HRLSC provides you with legal help in settlement negotiations or at a Tribunal hearing, and we will also help you to get results that can help others. For example, your employer, landlord or service provider may be required to:

- Stop discriminatory practices
- Make non-discriminatory policies
- Train all staff on human rights issues.
